Regarding your data that cannot be processed as per the aforementioned legal bases, processing the data is based on your consent prior to processing. Your personal data is not transferred domestically or abroad for any commercial purpose. Your personal data can only be shared with subsidiaries of SARKUYSAN if and only if we have your consent to do so.

SARKUYSAN has taken all necessary administrative and technical measures to protect your personal data and prevent any unlawful access. For further details related to the issue, please check our Company records at the Data Controllers Registry.

Your rights regarding your personal data are constitutionally preserved. You have the following rights regarding the processing of your personal data by SARKUYSAN;

- o Find out if your personal data has been processed,
- o Request information if your personal data has been processed,
- Learn the purpose of processing your personal data and whether or not they are used in accordance with the purpose,
- o Know the third parties nationwide and abroad to which the personal data is transferred,
- Request correction of your personal data if it is incomplete or incorrectly processed,
- o Request deletion or destruction of your personal data,
- Request that your requests for correction, deletion or destruction of your personal data be notified to third parties to whom your personal data has been transferred,
- Object if there happens to be an outcome against your party by means of having your data processed exclusively through automated systems,
- o Claim compensation for the damage arising from the unlawful processing of personal data.
